Art.4 Free Selection

No fee is requested to participate to the selection.

Only the selected artists who confirm their participation in the virtual art exhibition will be requested to pay a participation fee of 15 euro. This fee is the equivalent to the registration in our Art Association.

For the artists already registered this year in our "Association Grifio Art Gallery", the participation to this virtual art exhibition is completely free.

The registration allows the artist to have the following facilities:
